- 3. Psychology Elective Requirements: (12 creElit Ae\:fFS) Any psychology course taken for a letter grade can be used to fulfill the requirement for electives. These courses must be upper level (3000 or 4000) courses. Students must have at least 36 credits hours in total of upper division h ours for the psychology major. Students may, with the permission of the instructor, enroll in either PSY 4916 Independent Research in Psychology, or PSY 4941 Independent Field Experiences in Psychology, which are given pass/fail grades. A maximum of 6 credits of PSY 4916 and/or PSY 4941 can be used to satisfy Psychology Elective Requirements.
- **4. General Electives:** The College of Arts and Sciences requires that, in the last 60 semester hours of enrollment, students must earn at least nine semester hours through coursework outside the major department. These courses can be either lower division or upper division courses.

Students may, with the permission of the instructor, take PSY 4900 and PSY 4914, which are given Pass/Fail grades. These courses cannot count in the category of Psychology Elective Requirements, but they can used as additional credit towards graduation.
