- Approval of Academic Calendar Shells 2017 2018 & 2018 2019 Kevin Coughlin,
   University Registrar
  - Spring 2016 is 17 weeks long.
  - Start of finals week coincided with entire week of Passover. Changes were made to accommodate the holiday.
  - Calendars are aligned with other Metropolitan Universities.
  - Mini term affects when Fall term begins. Students should have grades available before they can register for the next term.

- Draft policy will be reviewed at the February 23 meeting.
- Once policy is drafted, send draft to University Counsel

  - Original APPC motions tabled by the Faculty Senate Steering Committee.
  - FS needed additional clarification on syllabus statement and listing of Holy Days.

### **Original Motion (tabled):**

The APPC recommends that Official University Policy on the Observance of Religious Holy Days be approved. The motion was approved unanimously with no change, but suggests that the following statement be added to the syllabus template: "A student who desires to be excused from class to observe a holy day of his or her religious faith should notify all of his or her instructors preferably upon receipt or access to the syllabus, and no later than the end of the second week of class."

## Revised motion, to be resubmitted to Faculty Senate:

The APPC recommends that Official University Policy on the Observance of Religious Holy Days be approved. The motion was approved unanimously with no change.

# Original Motion (tabled):

The APPC recommends that Academic Affairs create a list of all major religious holy days to be posted on the Faculty Resource page. The motion was approved unanimously.
