Government Relations/Legislative Update

➤ Chancellor Marshall Criser — to visit FIU for a Special FIU Senate meeting April 4 (pending approval by Senate) to discuss Performance funding and other issues affecting the SUS and FIU.

> FIU Day - Feb. 17, 2016

Governmental Liaison Teresa Lucas, UFF President Ben Baez, President Rosenberg, VP for FIU Governmental Relations Michelle Palacio, and Trustees Puig, Lowell, Grant, Pozo, Calatayud and Wilson as well as FIU students, met with Legislators from the Miami-Dade Delegation and presented Senator Gwen Margolis with a service medallion. Talking points included advocacy for Campus Expansion, Facilities Funding (SIPA, Satellite Chiller Plant), FIU Start-up, FIU UP: LIFT (Gateway courses, learning technologies, etc.) and Royal Caribbean (2.5 million to remediate mold in housing at BBC).

- Performance Funding and Emerging Preeminent Universities
- Fine House passed HB 7043, by Representative Erik Fresen, and the companion, SB 524 by Senator Don Gaetz, relating to performance funding and emerging preeminent universities. The bills add wage thresholds to the performance funding metrics; requires the Board to develop an implementation plan to include a metric that address the full-time employment rate of 90 percent of graduates for each university's top two baccalaureate degrees; requires the Board to establish minimum performance funding eligibility thresholds for the state's investment and the institutional investment in performance funding; clarifies that a university that fails to meet the institutional threshold will lose all of their institutional investment; and provides parameters for the selection of and terms of service for the chairs of state university boards of trustees and outlines requirements related to boards of trustees meeting attendance and the posting of meeting minutes. Additionally the bills create an "emerging preeminent state research university" category for any university that meets at least six of the 12 academic and research excellence standards identified in law and establishes the "Best and Brightest" Teacher Scholarship Program.
- The University of Florida and the Florida State University are designated as **preeminent state research universities** because they meet at least 11 of the following 12 criteria:
- An average weighted grade point average of 4.0 or higher on a 4.0 scale and an average SAT score of 1800 or higher for fall semester incoming freshmen, as reported annually.
- A top-50 ranking on at least two well-known and highly respected national public university rankings, reflecting national preeminence, using most recent rankings.
- A freshman retention rate of 90 percent or higher for full-time, first-time- in-college students, as reported annually to the Integrated Postsecondary Education Data System (IPEDS).
- A 6-year graduation rate of 70 percent or higher for full-time, first-time- in-college students, as reported annually to the IPEDS.
- ➤ Six or more faculty members at the state university who are members of a national academy, as reported by the Center for Measuring University Performance in the Top American Research Universities (TARU) annual report.
- Total annual research expenditures, including federal research expenditures, of \$200 million or more, as reported annually by the National Science Foundation (NSF).

- ➤ Total annual research expenditures in diversified nonmedical sciences of \$150 million or more, based on data reported annually by the NSF.
- ➤ A top-100 university national ranking for research expenditures in five or more science, technology, engineering, or mathematics fields of study, as reported annually by the NSF.
- ➤ One hundred or more total patents awarded by the United States Patent and Trademark Office for the most recent 3-year period.
- Four hundred or more doctoral degrees awarded annually, as reported in the Board of Governors Annual Accountability Report.
- Two hundred or more postdoctoral appointees annually, as reported in the TARU annual report.
- An endowment of \$500 million or more, as reported in the Board of Governors Annual Accountability Report
- The bill modifies preeminence metrics as follows:
- ➤ Aligns the required average SAT score for incoming freshman with recent changes to the SAT examination scoring.
- > Specifies that the U.S. News and World Report rankings is one of the rankings that should be considered for the Top-50 Ranking requirement.
- Adds the official membership directories maintained by each national academy as a source for verification of recognition of faculty members in a national academy.
- ➤ Includes professional degrees awarded in medical and healthcare disciplines in the calculation of the number of doctoral degrees awarded annually.

> Access and Affordability

HB 7019, and the Senate companion, **SB 984** by Senator John Legg, Postsecondary Access and Accountability, by Representative Elizabeth Porter, passed the House with one dissenting vote. Among other items, the bill specifies the cost of required textbooks and other instructional materials must be posted at least 45 days prior to the first day of class; requires each state university to publicly notice any proposal to increase tuition at least 28 days prior to it being considered at a BOT meeting; and requires the Board of Governors to annually identify strategies and initiatives to promote college affordability.

> Tuition and Fee Exemptions

The House unanimously passed **HB 799** by Representative Bryan Avila. And the Senate passed **SB 944** by Senator Garrett Richter. The bills create an out-of-state fee waiver for an active duty member of the United States Armed Forces residing or stationed outside of the state at the time of enrollment at a state university.

> Faculty Governance

- Senate representation in New Colleges. 62 Senators, apportioned by number of faculty at FIU on March 1. Each new college should develop internal policies to address issues of representation within the college.
- Bylaws must be in accordance with Senate Bylaws, AA policies and approved by the Dean and Provost.
- Administrative Appointments Senate Steering committee requests that the policy to appoint Chairs be extended to include Directors who have supervisory responsibilities. i.e. "Any administrator who has supervisory responsibilities and evaluates faculty on a regular basis should be appointed/chosen with faculty involvement (institutes, centers, schools, etc.)."

Strategic Plan

New budget model – 1.5% of ENG for each college to be "held back." 50% of vacant positions will be reallocated. 50% will go to student success, pre-eminence, or interdisciplinary programs. Need for clarity recurrent searches, visiting lines, etc.

➤ **Fulbright.** FIU one of top producers of Fulbright scholars among research institutions (6 scholars) behind ASU with 10, UF with 8, and FSU with 7. Gitta Montoto and Kathleen Wilson campus Fulbright reps. Fulbright application workshop April 1, 2-5pm in ACH4 room 402. Video-conferencing to BBC will be available. If enough demand a morning session will be added as well. August 1 Fulbright application deadline.

- Nature Preserve Many students and faculty are very concerned about the impact on the nature preserve of the proposed plan to construct two sports practice fields. Currently over 37 classes use the nature preserve as well as a number of faculty, including one with 7 million in NIH grant funding to study the Zika virus.
- ➤ The FIU Faculty Senate Environment and Planning Committee believes that any loss of the Preserve area would be a setback to this extremely vital campus asset. The Preserve provides incalculable value to students, teaching, research, and the environment, especially in the context of FIU's urban campus and the university's strategic commitments to the environment, arts and health. The committee also recognizes the challenge of having to accommodate our growing university's needs and the imperative to balance the many demands on our campus within a limited campus area.
- ➤ FIU Facilities and the Office of Finance and Administration assessed the originally proposed location west of the stadium and determined that given the expenses of road realignment, utility infrastructure costs, inefficient layout for athletic team use, and safety concerns over building sports fields next to a main thoroughfare, a new location should be considered. As an alternative to mitigate the above concerns, Facilities and the Office of Finance and Administration studied the construction of the practice fields in the northern area of the Nature Preserve and assessed that this new location would represent a savings of \$1.3 million and would offer better proximity to the student gym and housing.
- ➤ The FIU Office of Sustainability currently manages the Nature Preserve and operates under the FIU Department of Parking and Transportation. The total maintenance budget for the Preserve is approximately \$10k annually.
- ➤ The Environment and Planning Committee discussed its concerns with the removal of any part of the Preserve over the course of several presentations and meetings in January and February 2016 with Dr. Kenneth Jessell (FIU CFO & Senior Associate Vice President for Finance and Administration), Alexandra Dutton (FIU Office of Sustainability Manager), John Cal (Associate Vice President, FIU Facilities Management), and EAP ex-officio members, Tony Vu (University Treasurer), and Bob Griffith (FIU Director of Facilities Planning).

Resolution:

The Environment and Planning Committee recommends approval of the sports practice field construction in the northern Preserve area provided that the following conditions are agreed to as mitigation for said construction:

- Limit the removal of the northern Preserve Area to 2.82 acres in exchange for an addition of 2.95 acres, per the reference images in APPENDIX A (Figs. 2-4). The new area boundaries will be sustained into perpetuity for the purposes of research, teaching and recreation.
- Allocate \$2 million to a Nature Preserve Endowment and Improvement Fund that will be used solely to fund improvements to the Nature Preserve and campus natural areas. The Environment and Planning Committee will be responsible for recommending a mechanism to administer and approve the expenditure of said funds.
- Develop a Sustainability and Connectivity Plan for MMC and BBC that comprehensively evaluates campus sustainability and open space connectivity, provides specific guidelines for environmentally-sound policies that connect designated Campus Park & Natural Areas and expands these to include other undesignated areas (e.g. the pond area west of Law School), recommends strategies that minimize pollution, waste generation and resource consumption and are sensitive to the protection of campus flora, fauna, ponds, and other natural areas. Such a plan shall be commissioned from a third party and be adopted as university policy.

- Implement mitigation measures for all Campus Park and Natural Areas in accordance with the above Sustainability and Connectivity Plan. In particular the University will institute a no-spray policy and establish a littoral edge with native vegetation around all campus ponds.
- Designate other areas for the organic garden should the current area west of the Preserve be affected.
- Stipulate that the new sports fields will be available for a minimum of 20 hours/week for non-athletic team use.
- Include the FIU Nature Preserve as part of the University Capital Campaign by offering naming rights for the Preserve and allocating any funds generated from said process to the Preserve Endowment.
- Retain the existing tree buffer between the soccer field and the proposed practice fields in order to create shaded public space that can be active even when there is no field use
- Reroute the perimeter jogging trail around the proposed fields
- ➤ Meet and Greet (Happy Hour) Friday Feb. 26 in Faculty Club, from 4-6 pm, sponsored by the College of Law. Next (and last) Meet and Greet April 15, sponsored by CARTA. Note that ALL faculty (including part-time) are invited.

- Over 50 students attended this meeting to voice their concern of the building over the FIU Nature Preserve.
- Ken Jessell spoke to students concerns of the building of practice fields over the FIU Nature Preserved
- Over 6,000 signatures have been collected
- Ken Jessell spoke of the need for the practice fields, and these practice fields are for all students
- Students having to be turned away for the use of current field. He also mentioned that the current field is used until 1:00AM.
- o FIU is the only institution who do not have a practice field.
- \$8.9 million will be the cost of the proposed two fields
 - \$500,000 contribution made by SGA
- o BOT approved proposal on December 9, 2015

Golden Panther Express:

- Provost and CFO are still identifying the most efficient means to handle faculty reimbursements for the Golden Panther express.
- Discussions are underway with parking and transportation on either issuing new cards to faculty for use on the GPE or having faculty perform departmental reimbursements for travel.
- Based on data from parking: there were 4,143 faculty GPE riders in the Fall 2015, but only 215 of those were faculty who were assigned to teach at BBC. Office of the Provost is still validating the data.

Ben Baez and Teresa Lucas participated as faculty representatives in FIU Day in Tallahassee, along with President Rosenberg, members of the BOT, and representatives of the Student Government. Ben and I joined the students in visiting senators, representatives, and the Chief Financial Officer Jeff Atwater.

Legislation

Performance Funding

The Florida Legislature enters the final two weeks of session today. SB 524 that includes provisions regarding Higher Education is up for a full Senate vote. However the bill is different from the bill already passed by the House, so the bills will have to be reconciled during the next two weeks to be passed and sent to the Governor's Office.

SB 524 codifies into law the following: performance based funding for the State University System, the Preeminent State Research Universities Program, performance based funding for

the State College System, the Best and Brightest Teacher Scholarship Program (for public school teachers), and liability insurance for public school teachers

Changes to performance funding metrics include: employment threshold for graduates of over \$25,000;_100% employment for degrees having the most graduates (for FIU: psychology and business management); and withholding all performance funding from universities that fall in the bottom tier of performance points.

• Guns on Campus fails

Senator Miguel Diaz de la Portilla, from Miami-Dade District 40, refused to bring SB 68 to the Judiciary Committee, killing the bill, the companion of which had passed in the House (HB 4001). Knowing Your Rights And Understanding Common Issues
 The first e-mail blast of every month will present one topic from the Collective Bargaining
 Agreement (CBA) that affects every FIU faculty member. The creation of this series is the result
 of a suggestion at our UFF Spring Chapter meeting. It is part of our ongoing effort to inform all
 faculty not only of their rights under the CBA, but to inform all faculty of the value of being a
 UFF member. Our CBA is the outcome of years of dedicated UFF Bargaining teams who see

value in protecting our rights. Lastly, this is a legally binding agreement and must be adhered to by all parties.

• Article 11: Salaries

11.3 –2015-2018 Discretionary Awards and Increases.

During the 2015-2016 academic year, the 2016-2017 academic year, and the 2017-2018 academic year, the FIU Board of Trustees or designee may provide additional salary increases and/or one-time awards totaling no more than one percent (1.0%) of the total employee payroll as of the last full pay period of the prior academic year. These increases may be provided for market equity considerations, including verified counteroffers and compression/inversion; increased duties and responsibilities; special achievements; Summer Faculty Research Awards; litigation/settlements; and similar special situations. No later than July 30 of each year, the University shall provide a listing of the distribution of these funds to the local chapter of UFF. This list will provide the name and department of the employee and the date, amount and nature of the award or salary increase during the prior academic year.

What does this mean?

FIU administration receives 1% of the total of all faculty salaries that may be used at their discretion. This means that if you are affected by any of the above considerations, you may ask to receive a discretionary award as an increase to your salary. I advise faculty to first ask for a face-to-face meeting with your immediate supervisor to discuss why you are asking for a discretionary award. I would then advise that you follow-up with an email thanking your supervisor for considering your request and include what was discussed. In this email, please document and include any relevant data and/or any information that supports your position. Your initial request is to your supervisor in person, then by email. Ask your supervisor to forward your email, along with (hopefully) their written support in the same email, to the dean and to cc: you. If you have any questions regarding this, I am available to discuss and review the process.
