1. Minutes. Review and Approval of Minutes from 30OCT2013 Meeting

2. Discussion:

- 1. Recycling on Campus: John Cal
 - a. Joe Nuninga in charge of FIU recycling
 - b. FIU has Single Stream, leading edge recycling since 2009
 - c. Effectiveness: 2nd in state after UF
 - i. Events support awareness: Recycle Mania
 - d. Recycling operation is normal/routine
 - e. Campuses have multiple container types, but unifying/replacing these across campus would be costly; might not necessarily impact effectiveness of recycling program
 - f. Aramark jurisdiction on waste management: some issues that can be improved

2. Recycling on Campus: Joost Nuniga

- a. Re: difference in bins across campus: problem of replacing bins is cost:
 - i. looking at options with OOS (labels by OOS pending approval)
 - ii. Recycling totes are standard
 - iii. All bins are single stream bins
- b. Two bins arrangement is popular trend: regular trash and recycle bins

- c. 2013 solid waste-recycling data for BBC, MMC, EC campuses provided
 - i. might not include non-E&G buildings like GC, for example)
- d. Bins at PC/Betty Chapman: brown an blue labels; still evaluating this pilot project
- e. Costs:
 - i. over \$100k to replace bins on campus
 - ii. Concrete bins are \$500/ea
 - iii. Ryan Vogel: what would the cost be to pair the bins?
 - 1. JN: would still require purchasing additional bins
- f. Roberto Rovira: would there be any issues with sponsored bins? JC: no issues
 - i. Q: Are there examples of sponsored bins?
 - 1. OOS can look at branded bin examples
 - ii. Mahadev: would Waste Management or others be interested in sponsoring signs? JN: No
- g. JN: ea. office collects its own recycling within buildings
- h. Peter Craumer: what are the contamination issues or pushback from provider?
 - i. JN: currently have less than 10% by weight contamination
 - 1. (15% is the contract limit for contamination)
 - ii. JC: Behavior/compliance is good
- i. Styrofoam: banning is very difficult for labs, but business services CAN require no Styrofoam of its vendors
- j. Ryan Vogel: Aramark contract leaves room for interpretation; they handle "waste"
 - i. JC: FIU Facilities can review contract and ask Aramark to pick up recycling in exterior bins (Betty Chapman Plaza, for example)
 - 1. Nick diCiacco oversees the Aramark contract.
- k. Mahadev: if we can improve branding we can increase collection
 - i. JC: volunteer custodial staff to attach signage
- I. JC: Facilities has been asked to increase trash bins vs. reduce bins
 - i. Unlike other institutions where reducing the number of bins is encouraged
 - ii. Tony Vu: Q: Who pays for the bins now? JC: Facilities does; to increase number of bins, need additional funding
- m. Vogel: New buildings: whenever a new building gets built they should go through Facilities to get the proper bins that are consistent throughout; should be standard procedure vs. leaving it to the new building staff
 - i. Q: Can there be a policy that requires the above?
- n. JN: Have data from waste audit
- Mahadev: How many bins do you buy each year to replace broken ones?
 JN: amount is not that significant

- p. JN: Athletics is another area that could improve
 - i. Contracts are on an event basis
 - ii. JC: Costs of pairing trash cans at tailgates; marginal costs vs. reacting and picking up after the event; Facilities can look into this
- q. Athletics & Graham Center: invite them to future meeting (see INVITATIONS below)
 - Need to understand current situation and desire to have support across the board; recycling as priority; how can they be a part of the solution

r. ACTIONABLE ITEMS/RECOMMENDATIONS:

- i. SIGNAGE: attach new signs (pending approval) to bins [Custo-dial staff & OOS]
- ii. SPONSOR: look at branded bin examples [OOS Research]
- iii. CONTRACT: Review Aramark contract and identify possible improvement areas re: recycling/waste management [Facilities]
- iv. PROCUREMENT: When we procure new bins as replacements and/or for new buildings make a consistent choice whenever possible [Facilities]
- v. INVITATIONS: Graham Center & Athletics to future EAP meetings [EAP]
 - Invitation to Carlos Carrasco (in charge of Recycling at GC) to EAP committee meeting on Wed. 22JAN2014
 - 2. Athletics invitation pending

3. LEED on Campus: John Cal

Zs. f. Lin

- a. Maidique signed the Climate Change agreement
 - i. FIU would pursue LEED SIlver on all new construction
 - ii. MBR reconfirmed the commitment
- b. All new construction has been LEED Silver certified LEED with some Gold
 - Exception is PG5 Market station but the parking portion is so large that it can't be achieved there
- c. Also looking at building performance in energy performance
 - i. "The greenest most renewable form of energy is the energy we don't use"
- d. FIU led SUS in KW / sf: report is in the Facilitieswebsite
- e. EXT. 4600: Dial for any facilities management work orders
